The Standards Library maintains databases on and search tools for standards. It provides all users with a free insight into standards and professional assistance. Its staff also provides free advice on standards by phone or e-mail.

The HZN Standards Library's holdings and services contribute to better involvement of SMEs in standardization activities aimed at representing their interests at the national, European and international levels.

HZN's workshops for SMEs

In 2013 HZN organized two workshops for SMEs.

The first workshop, "Standards – big benefits for small business", was held on 8 February 2013 at Ulica grada Vukovara 78, Zagreb, in cooperation with the Ministry of Entrepreneurship and Crafts (MINPO), the Croatian Chamber of Economy (HGK) and the Croatian Employers' Association (HUP). It was a part of the European SMEST 2 project aimed at strengthening and promoting relations between SMEs and standardization.

The objective of the workshop was to inform SMEs of the benefits of the implementation of standards and on how to use standards to improve efficiency and competitiveness, reduce waste and costs, ensure quality and safety of products and services and facilitate their sale throughout Europe and globally.

The workshop has provided a unique opportunity for representatives of SMEs to see on the examples of good practice how to improve their businesses by implementing standards and participating in European and national standardization. More than 50 representatives of SMEs took part in the workshop. In the evaluation forms they gave the highest ratings to the workshop as a whole, the topics and the moderators.

The other workshop, "HZN at the service of SMEs", took place on 28 November 2013 in the Large Hall of the Ministry of Economy, Ulica grada Vukovara 78, Zagreb, within the European SME Week 2013 campaign.

The aim of the workshop was to inform SMEs on contact points at HZN, government authorities and public institutions that support micro, small and medium-sized enterprises. The information and contact points at the Croatian Standards Institute (HZN), Ministry of Economy (MINGO), Ministry of Construction and Physical Planning (MGIPU), Ministry of Entrepreneurship and Crafts (MINPO) and the Croatian Chamber of Economy (HGK) have been presented. At the event, acknowledgements for the exceptional contribution to standardization have been awarded to HZN members.

More than 60 participants took part in the workshop. In the evaluation forms they gave the highest ratings to the workshop as a whole, the topics and the moderators.

Participation in both workshops was free of charge, upon prior registration.
